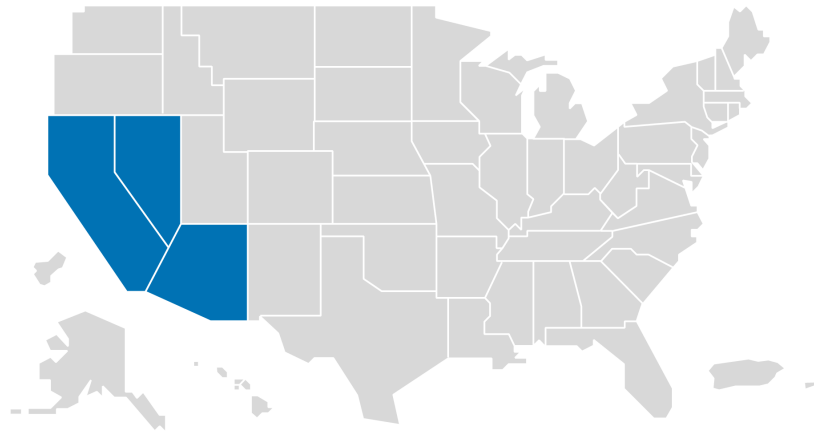

The mission of Native American Connections is to improve the lives of individuals and families through behavioral health, affordable housing and community development services that are culturally appropriate for Native Americans. A \$650,000 grant from the Federal Home Loan Bank of San Francisco’s Affordable Housing Program, delivered through Republic Bank of Arizona, was part of the total funding package for our Encanto Pointe development, which is a permanent supportive-housing community for people experiencing chronic homelessness. It opened in 2013 and leased all units in less than 60 days. Valley of the Sun United Way provided funds for supportive services, and after the first year of operation it conducted a health study for us. This study revealed how well a “housing-first” model can work in our community: the rates for emergency room visits for Encanto Pointe tenants were reduced by 85 percent compared to the prior year, and jail involvement was reduced to zero.
